

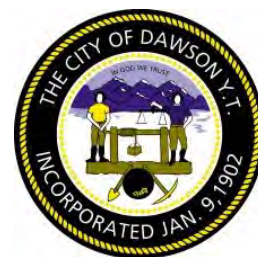

Now that the process of getting the nomination package for the Tr'ondëk-Klondike World Heritage proposal is nearly complete, it is a good time to reiterate the position of the Dawson City Chamber of Commerce with regard to this project.

The chamber has had representatives on the advisory committee behind this proposal since its inception and has been pleased to see the incredible progress that has been made since the project shifted into high gear in 2013.

In its current iteration the package supports the notion that the statement of universal value justifying the nomination reflects understanding of the long heritage of the Hän people in this region as well as the world recognition that came to the area with the Klondike Gold Rush between 1896 and 1898. That the two quite different cultural threads have been woven together over the last 120 years is remarkable. That mining still exists as a thriving economic pillar at the same time as the Hän culture is experiencing a renaissance is also remarkable.

That this nomination seeks to support all of this is encapsulated by the very title Tr'ondëk-Klondike, as the first word, in the Hän language, is the very linguistic source of the second word.

A UNESCO designation will unify community pride in hosting and safeguarding one of the world's special places. One of our economic pillars is tourism, and this status will help to sustain the existing visitor traffic while also attracting another kind of visitor. Tourism provides jobs and business opportunities here, and a stronger economy will have positive social, cultural, and economic benefits for Dawson and for the rest of the Yukon.

The Dawson City Chamber of Commerce continues to support this existing and worthwhile project.

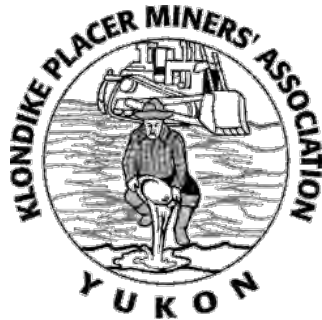

Klondike National Historic Sites are owned and managed by the Parks Canada Agency, and comprise 5 national historic sites located within the Klondike Region in central Yukon. Since the Klondike region was placed on Canada's tentative list for World Heritage nomination, Klondike NHS has been a strong supporter of this project.

The Historic Sites and Monuments Board of Canada (HSMBC) is responsible for reviewing and recommending the designation of Canada's nationally significant persons, places, and events. The importance and significance of the Klondike region to the history of Canada and the world is well illustrated by the fact that there are 20 HSMBC designations with plaques located within this region. This includes 10 National Historic Sites, of which 5 are owned and managed by Parks Canada and the remaining 5 are owned and managed by other community interests which include other levels of government (including First Nations), the private sector, and religious denominations. Dawson City is a community steeped in history, and as a community takes great pride in sharing the many stories that are a part of this history.

This community pride and commitment to preserving our history is most evident in the combined local effort to support the World Heritage nomination. All major organizations responsible for managing local heritage values, or with a vested interest in the historic themes related to this region have been actively involved in supporting and advancing this project. Community benefits are already evident with the strong and active project collaboration between governments at the First Nation, Territorial, Municipal and Federal levels. This is further strengthened by the active involvement of leading community organizations such as the Klondike Visitor's Association, Dawson City Chamber of Commerce, the broader heritage community, and participation of citizen representatives.
